Deciding to create the world's largest manmade harbour from scratch nearly 50 years ago required significant foresight and confidence. The bold, innovative approach paid off. Today, Dubai is a vital, world-class trade, logistics and manufacturing hub. Jebel Ali Port is the largest seaport in the Middle East and one of the world's top ten container ports, connecting the markets of East and West. Immediately next-door, the Jebel Ali Free Zone (Jafza) enables easy import, export and logistics as well as manufacturing.

Over the years, Dubai Trade has continued to expand its range of services – it currently offers a wide range of digital services, including Customs clearance, port operations, payment services, Free Zone services, voyage planning and management, cargo handling, digital payments, value-added services, permits and certificates, amongst others. The platform has also been updated to incorporate the latest technological advancements, ensuring that it remains a cutting-edge platform that meets the evolving needs of businesses in Dubai, says Mohamed AbuHamra.

AbuHamra describes Dubai Trade as a Digital Single Window constituting end-to-end trade and logistics services. The latest developments are designed to transform the platform, expanding to connect downstream services. Examples include a Digital Delivery Order Platform, which facilitates delivery order issuance between cargo owners and agents; a Food Supply Chain Integration Platform integrating the end-to-end food

supply chain, streamlining processes between multiple agencies and food importers; and Certificate Issuance for key trade documents such as the certificate of origin, automating the end-to-end export services.

By providing a streamlined flow of services designed around the needs of the customer and eliminating manual documentation and paperless trade transactions, Dubai Trade is absolutely aligned with the UAE's Digital Government Strategy 2025, says AbuHamra.

"This results in reduced waiting time and costs for shipping agents, freight forwarders and cargo owners. It also enriches logistics professionals through tailored orientation and certification courses."

The overall mission is to connect the end-to-end value chain, and to become the global leader in digital trade facilitation. Dubai Trade has just been welcomed as a new member of the International Port Community Systems Association (IPCSA).
